### PRESIDENT: VICENTE CRESPO (Vinny)

- I have completed the Leadership Institute. It was a great experience and one of the best trainings overall.
- Contract negotiations are still ongoing.
- Call to action: To oppose any cuts to Federal and Postal pensions, members are encouraged to call 844-402-1001 immediately.
- Some small offices and the main plant will be affected by upcoming changes.

### **VICE PRESIDENT: LLOYD BRAZEE**

- Reversions are happening, all retiree bids were reverted.
- Affected groups include four (4) ETS Level 10, thirteen (13) Level AMP, and two (2) BEM employees.
- Training is in Oklahoma, not at the Providence plant.
- Untrained employees are being placed on machines they have never been trained on or worked with before.

#### **CLERK CRAFT DIRECTOR: AYOBOLA AFOLABI**

- Management is giving out discipline for attendance problems. Union stewards are filing grievances and making sure members are represented.
- Everyone was reminded to do their assigned work and not say, "That's not my job." If management is performing bargaining unit work, let the Union know right away.
- If you're moved to another section, make sure the move is done properly.
- Stay united and support each other.
- There have been concerns about how job posting and reversions are being handled.
- The Union remains committed to protecting the rights of all members and ensuring fair treatment by management.

### MVS/VMF CRAFT DIRECTOR: WESLEY CARPENTER

- Runs have been rearranged.
- Pickups are now at different times.

# VMF STEWARD & MVS ALTERNATE STEWARD: WILLIAM KLINE

- March 12, 2025: Management told the Union about changes coming in two steps: April 1 and May 19.
- March 31, 2025: Start time change for one run effective April 5.
- April 16, 2025: Union received updated run schedules (4533 PVS).
- April 17, 2025: Management said 55 jobs would be reposted due to staffing changes.
- April 29, 2025: Management posted 48 preferred duty assignments for bid without discussion.

- May 6, 2025: Union asked management to stop posting jobs due to contract violations.
- May 7, 2025: Meeting with management about concerns on posted jobs (rest breaks, stop times, etc.). Management refused changes but agreed to review after implementation.
- May 9, 2025: Union submitted suggested schedule changes.
- May 12, 2025: Management rejected the Union's changes and will proceed with the original posted assignments.
- May 19, 2025: The new RTO assignments take effect.
- Management's RTO changes aim to reduce trips over 50 miles.
- Some changes to Tour 1 trips seem unnecessary and disruptive.
- If asked to do work not on your schedule or you feel undervalued, ask for a Steward immediately. These are contract issues.
