Minutes to the meeting

Charge#2- Mike Hall insulting Brian Yaghoobian. Violating Article 15.1, 2.6 and Sec 10 Members Bill of Rights. Mikes are on appeal with National Nov.29th. Reading of article 15.1 members bill of rights, Reading of memos [emails] Lloyd Brazee-Objects Unconstitutional Jim Continues charged- GUILTY - Suspended 60 days without pay effected as of today.

Charge#3- Every member has the right to be secure on his or her basic rights without fear of political, economic, physical or psychological intimidation. Article 15.1c. Article 2.6 and Sec 10 Members Bill of rights. Both parties were given 4 mins to address charge. Lloyd Brazee-Objects Jim- Should of came to the trial to Object!

Charge#4- All Convention delegates must attend all business sessions-meetings as directed. Article 6.3 local Constitution -GUILTY Both parties 4mins to speak Guilty by board and body agreed Guilty. Lloyd Brazee- Objects. Ann speaks to Lloyd about his outburst of objecting. Maintenance will have to vote on termination.

Charge#5-defrauding memberships money-double dipping.getting paid twice- by the union and filling a 3971. GUILTY- voted by the body-GUILTY.....Lloyd Brazee -Objects Ann again addresses Lloyd about his outburst

Charge#6- Engaging in conduct that would expose APWU to civil liability. Article 15.1c of national Constitution and Bylaw. - GUILTY Immediate removal by local of his title and be held responsible by any action that occurs from

Anyone. Immediate removal from Craft Director from PVD APWU for 5 yrs and be responsible For any trial board penalty.

Charges #4,#5,and# 6 maintenance will vote on these charges only.
